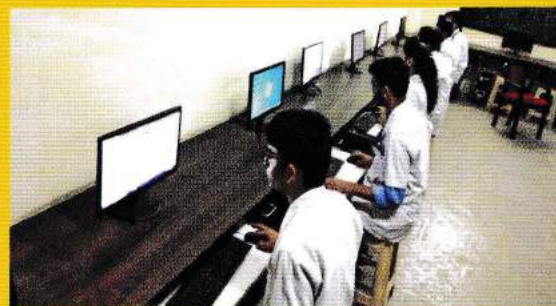


◆ Laboratories
